

## OFFICIAL RULES OF THE TICKETMASTER® SUPER BOWL LII SWEEPSTAKES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Eligibility:** The Ticketmaster® Super Bowl LII Sweepstakes ("Promotion") is open only to natural persons who are legal residents of United States of America or Canada (except Quebec) who have a valid social security or tax ID number, and who are at least eighteen (18) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. The NFL Entities (as defined below), Promotion Entities, prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. **Sponsor:** The Sponsor of the Promotion is Ticketmaster L.L.C. ("Sponsor").

  - c. Upload your Video with the one (1) required hashtag #TicketmasterNFLEntry and tag @Ticketmaster (the stated required actions are collectively an "Entry").
3. To enter without an Instagram or Twitter account, or Video, go to <https://a.pgtb.me/rqgZL5> and complete the Promotion registration form and submit ("Entry"). You may encourage your friends who are eligible to enter this Promotion ("Friend Referral") to enter by sharing via your Facebook, Twitter, google+, or Pinterest account, or your Personal Referral link. You will receive one (1) additional entry for each successful sweepstakes entry via your Friend Referral, for a maximum of two (2) Friend Referral entries. For Friend Referral to be valid, entrant must use the Share icons or the Personal Referral link on the Confirmation Thank You page that will display upon successful entry.

**For Instagram or Twitter Entry:** Video must be a new upload. If you wish to add the required hashtag to an existing Video, you will need to re-upload. Video shall be at least seven (7) seconds and no longer than forty-five (45) seconds. Video shall not violate the Instagram or Twitter platform terms of use. Entrant's Instagram or Twitter account must be set to public at time of Entry and until February 1, 2019, or until the winner has been verified, whichever comes first, as entries with a private account setting may not be captured. Promotion Entities are not responsible for the functionality of the Instagram or Twitter platforms, including changes that may interfere with the Promotion or the ability of a potential entrant to participate in the Promotion. **Content of Video will have no bearing on winner selection.**

3. Warrants and represents that entrant's Entry is original to the entrant and has been legally obtained and created, does not infringe the intellectual property, privacy or publicity rights or any other legal or moral rights of any third party, or violate applicable laws or regulations;

4. Entrants who are not yet at the age of majority in the jurisdiction in which they reside will be required to obtain parental or legal guardian consent to be eligible to be declared a grand prize winner (as hereinafter defined);

5. Warrants and represents that entrant's Entry does not contain any unlicensed images;

6. - Conduct or activities in violation of these Official Rules
- Any other content, display, materials and/or images that is or could be considered inappropriate, unsuitable or offensive, as determined by Promotion Entities, in their sole discretion.

**Prize:** One (1) Grand Prize consisting of a trip to Super Bowl LIII which includes two (2) reserved tickets to attend Super Bowl LIII at Mercedes-Benz Stadium in Atlanta, GA scheduled to take place on February 3, 2019; round-trip, coach class air transportation for two (2) from the major airport nearest Grand Prize Winner's home within the United States or Canada (except Quebec) to Atlanta, GA departing on February 1, 2019 and returning

on February 4, 2019; one (1) double occupancy standard hotel rooms for three (3) nights / four (4) days; and a \$200 pre-paid cash card to use toward ground transportation. Selection of airport, airline, hotel and game seat location are solely within Promotion Entities discretion. Winner and guest must abide by all stadium policies. Promotion Entities reserve the right to not award any prize to, or to revoke full or partial prize from, any winner or winner's guest who Promotion Entities and/or stadium personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any stadium, airline, or hotel policy or law, and/or may bring Promotion Entities into disrepute. All other expenses not specifically mentioned herein are solely the winner's responsibility. Winner will be required to provide a credit card to hotel to cover incidentals, which are not included in prize package. Administrator reserves the right to provide ground transportation in lieu of air transportation if the winner resides within two hundred (200) miles from either trip destination.
